Producers Invited to Attend Florida FSA County Farm Bill Meetings

The Florida Farm Service Agency and UF/IFAS Extension Service is hosting Farm Bill meetings on the following dates and meeting locations. The meetings are free and open to the public.

Meeting attendees will learn about Farm Service Agency (FSA) Farm Bill programs the Agricultural Risk Coverage (ARC) and Price Loss Coverage (PLC).

UF/IFAS Extension Service Agents will demonstrate the online decision-making tools that are available to producer to help make important enrollment decisions regarding ARC and PLC programs. Learning more about ARC and PLC is extremely important for producers who must make a one-time decision about base and yield updates as well as ARC or PLC election and enrollment decisions. An FSA representative will be in attendance to answer any questions on ARC and PLC policy and procedure.
